#### Introduction to the Treasurer

Being a Board Member usually means we operate 'behind the curtain' without many people knowing who we are, what we do, or even that we exist.

For those who do not know me, my name is Johnny Deem and I was elected Treasurer of Stonewall Sports Raleigh in July 2020. I moved to Raleigh two and a half years ago from Albany, NY where I served as Treasurer of Albany Empire Soccer Club Inc., upstate New York's only LGBT+ soccer club. For the past two years, I have loved every minute of being in Raleigh and Stonewall is the main reason for that. The league has provided me the opportunity to not only play sports, but to meet some amazing people and friends. I felt it was my turn to give back to this organization that has welcomed me with open arms. In my professional life, I work as a Certified Public Accountant (CPA) for a large international firm dealing specifically in Forensic Accounting and Regulatory Compliance.

One of my main goals when I began my term was to be more financially transparent to our Members. As each person pays to participate in the league, I believe they deserve to know how their fees are utilized by the organization. I also think it's important for our Members to understand the organization's fiscal processes and how finances play a part in the Board's decisions.

As the Treasurer, it is part of my responsibility to approve major purchases, compile all company transactions, create annual financial reports, prepare budgets, and file the required tax forms to the IRS. My term is two years and I'll continue to serve you all to my best ability during that time. I hope you take some time to review the Stonewall Raleigh Member Financial Report and get a further understanding of the organization.

Thank you for being a part of Stonewall Sports Raleigh Inc. especially during these turbulent times. This organization would not exist without you and we hope you continue to participate each season.

#### **Purpose of a Member Financial Report**

In every publicly traded company, those who buy stock are called shareholders. When a company has shareholders, they are required to publicly release their financial statements with an overview of the year's fiscal performance. This publicly released document is called a Shareholder's Annual Report. Since our members pay to join a league sport every season, I wanted to create a document that is similar to a Shareholders Report; thus, this document is called the Stonewall Sports Raleigh Member Financial Report and it will include the financial statements for 2019, 2020, and 2021 as well as an overview of each year's activities.



I firmly believe it is vital to inform our Members how the organization is operating each year. Going forward, my plan is to release a Member Financial Report at the end of every year. Since Stonewall Sports Raleigh Inc. became independent of the LGBT Center of Raleigh as of June 2019, the organization only became responsible for our own finances starting then. It is part of my responsibility to track these finances and guide our organization to make better fiscal choices. Since the average person doesn't understand financial statements, I've also created an 'Explanation of Terms' section so you can understand what terms mean and what costs are included in each classification.

2019, 2020, and 2021 all presented unique challenges for Stonewall Sports Raleigh: the organization was officially started, COVID-19 began, and the organization had to cancel some sports seasons every year since 2020. This report also includes a section that let's our members know what the organization is planning for 2022.

I hope you'll read through this report to understand where we were, where we currently are, and where we are going in the next few years.



#### **History of Stonewall Sports Raleigh**

The Raleigh chapter of Stonewall Sports began in the Fall of 2013 with Kickball being the first sport. In that season, there was eight teams signed up with a total of 165 members and even one original kickball team that still exists today (Sir Walters). Since then, the organization has expanded to nine sports and over 11,000 members including hosting the National Stonewall Sports Tournament in the summer of 2019. Look at the chart below to see the past sports, number of teams, and number of participants throughout the years.

From 2013 to June of 2019, Stonewall Sports Raleigh operated under the LGBT Center of Raleigh. During that time, the LGBT Center oversaw all financials and reporting to the National Stonewall Board. Starting in June of 2019, Stonewall Sports Raleigh Inc wanted more control over the future of the club and officially filed for Not-For-Profit (NFP) status with the IRS. Finally, in October of 2020, the organization was officially granted 509(a)(2) NFP status and therefore, are required to file annual tax returns. If anyone is interested in viewing past tax returns, please go to www.irs.gov and look under the Charities and Nonprofits section.



#### The Board of Directors

The Board of Stonewall Sports Raleigh consists of eight elected members who each serve twoyear terms (4 years maximum). The Board comprises of the following positions:

#### Commissioner – Dennis Learned (raleigh.dennis@stonewallsportsorg)

The Commissioner shall represent the Corporation in an official capacity where appropriate. The Commissioner shall serve as the official legal representative of the Corporation, and shall execute all contracts, permits, and other documents with legal significance. The Commissioner shall be the only Director with the authority to transact business on behalf of the Corporation.

The Commissioner shall be responsible for carrying out the policies and directives of the Board.



The Commissioner shall preside at meetings of the Board of Directors and shall perform such duties as usually pertain to the chief executive officer of a corporation, together with such additional duties as the Board of Directors may assign.

The Commissioner shall only cast tie-breaking votes unless otherwise specified herein.

#### Athletic Director – Larry Leslie (<u>raleigh.larry@stonewallsports.org</u>)

The Athletic Director shall be responsible for maintaining the overall contact list of Registered Participants and Informational Participants.

The Athletic Director coordinates the registration process of each Sports League

The Athletic Director shall meet with the Sports Directors at their discretion and shall report to

the Board of Directors matter relevant to Board Activities during regularly called meetings of the Board.

The Athletic Director shall oversee the day-to-day operations of all sports and recreational activities offered by the Corporation.

The Athletic Director shall be the final authority on publishing rulebooks for each sport and shall serve the arbiter of any disputes relating to the implementation of the rules.



#### Treasurer – Johnny Deem (<u>raleigh.johnny@stonewallsports.org</u>)

The Treasurer shall be responsible for managing the Corporation's bank accounts, receipts and disbursements, and for keeping complete and accurate records thereof.

The Treasurer shall be responsible for preparing or supervising the preparing and filing of the IRS Form 990 information return each year and providing copies thereof to each Director.

The Treasurer shall be responsible for filing and paying the Corporation's annual license renewal fee and similar registrations required by government agencies.

The Treasurer will make disbursements to charitable organizations upon direction of the Board.

The Treasurer shall be responsible for preparing an annual financial statement of the Corporation and shall issue other financial reports to Board members as requested by the Board.

The Treasurer shall arrange for an annual independent review or audit of the Corporation's financial books and records, and shall ensure that the report of such review or audit is timely presented to the Board.



The Treasurer will assist the Sponsorship Director with identifying and negotiating sponsorship opportunities the Treasurer shall have final approval of all Sponsor Agreements.

#### Communications Director – Kris Jaggers (raleigh.kris@stonewallsports.org)

The Communications Director shall be responsible for updating and monitoring the web site and maintaining the corporation's social media presence.



The Communications Director shall be responsible for maintaining the overall contact list of Registered Participants and Informational Participants.

The Communications Director shall seek earned media opportunities to promote the Corporation, its members and its special events.

The Communications Director shall be available as a resource

to assist each Sports Leagues and the Events Director in the performance of their communications functions.

#### At-Large Director of Sponsorships – Tommy Crompton (raleigh.tommy@stonewallsports.org)

The At-Large Director of Sponsorships shall perform such tasks necessary to effectuate the provisions of Article IV, including but not limited to supporting the Commissioner, Technical Director, Treasurer, Communications Director.

a. The At-Large Director of Sponsorships shall be the primary officer tasked with obtaining and maintaining sponsorship relations

b. The At-Large Director of Sponsorships shall be tasked with ensuring contractual obligations are met and that dues are paid.

c. The At-Large Director of Sponsorships shall maintain regular and continuous engagement with the sponsors of the league.

d. They shall track donation pledges and submissions as well as monitor the league's support and promotion of each sponsor.

e. The At-Large Director of Sponsorships shall be responsible for leading all sponsorship efforts for each sport working with the other Directors of the Corporation. They shall be the main point of contact for the solicitation, confirmation and ongoing communication between the league and its sponsors.



At-Large Director for National Board Representation – Davey Goodhart (raleigh.davey@stonewallsports.org)

a. The At-Large Director and National Board Representative shall represent the interests of Stonewall Sports Raleigh at the national level and report back to the Board of Directors as needed.

b. The At-Large Director and National Board Representative perform such tasks necessary to effectuate the provisions of Article IV, including but not limited to supporting the Commissioner, Technical Director, Treasurer, Communications Director and, At-Large Director of Sponsorships.

# *Diversity, Equity, and Inclusion Director (DEI Director) - Nijsha Johnson (raleigh.nijsha@stonewallsports.org)*

The Board shall appoint a Representative to the National Diversity, Equity, and Inclusion (referred throughout these bylaws as DEI) Committee who shall report back to the Board on the activities of this Committee as needed through a Board appointed Liaison.

#### Secretary – Accepting Applications Now!

The Secretary shall be the recording and certifying officer of the Corporation.

The Secretary shall have custody of the Corporation seal and the other official records specified in Article X of these Bylaws.

The Secretary shall provide notice of Board meetings and shall keep the official minutes of such meetings.

The Secretary shall maintain the Public Inspection File required by the Internal Revenue Service, and shall be responsible for responding for requests from third parties for access thereto.





#### **Explanation of Terms**

The explanation of terms section is included for everyone to understand what the classifications within the Statement of Activities mean as well as what kind of costs are included.

#### Revenues

Revenues are the total amount of money received for each corresponding sport for the year. These totals represent the total sport fees minus the Stonewall National Membership Fee (4% of total), Credit Card Percentage Fee (2.30% of total), Credit Card Dollar fee (\$.15 per transaction), League App fee (2% of total), and Wire Fees (\$1). As a side note, all funds are booked through LeagueApps, which is controlled solely by Stonewall National and not Stonewall Raleigh. After every season begins, Stonewall Raleigh must request these funds directly from Stonewall National. Revenues also include any money received from sponsored companies as well as any other non-classified money received.

#### Service Expenses



Service expenses are classified into Legal Fees (those fees associated with legal advice or services requested), Professional Fees – other (any other fees not associated with legal or banking fees), and Bank Fees (those fees from banking transactions).

#### Non-Personnel Related Expenses

These expenses include a variety of general administration related costs including Supplies and Materials (general costs related to all sports and any other supplies), Postage & Shipping, Storage Rental, and Software costs (Quickbooks and Website fees).

#### Member Events

These are costs associated with any events hosted by Stonewall Sports Raleigh for all members. Once the COVID era is done, the organization wants these costs to increase as they would like to start planning more fun events for our members.

#### Program Expenses

Program expenses include all costs for each sport. These costs are further classified into Field/Court Rentals, Equipment Purchases, Uniforms (T-Shirts), Umpire/Referee Fees, and Medals and other.



#### Travel & Meeting Expenses

These costs include any costs for Travel (hotel stays for tournaments, etc.) and any fees for Conferences, Conventions, and Meetings.

#### Other Business Expenses

These business costs include any costs not associated with admin, travel, and program expenses. Notable costs include the annual insurance costs, Staff Development (any board and SEOC related development), Advertising costs, Fundraising costs, Meals (monthly board meetings), and Donations.



#### Specific Assistance – Individuals

These costs are associated with unapproved board expenses that are will be paid back to the organization starting in 2022.

#### Interest Earned

Interest Earned is solely from interest earned on bank saving accounts.

### 2019

2019 was a very pivotal year for Stonewall Sports Raleigh Inc as it was the year the organization split from the LGBT Center of Raleigh and became our own independent not-for-profit organization. Ultimately, by becoming our own organization, it allows the Board more freedom to decide where to lead the organization. Another key benefit to becoming our own organization is having direct control over finances. From 2013 to June of 2019, Stonewall Sports Raleigh was primarily controlled by the LGBT Center of Raleigh. Although the organization still had an executive board, whose main responsibility was to run the day-to-day functions of Stonewall Raleigh, they had no control over purchases, deposits, or donations from each season. Since they officially became an independent not-for-profit organization in June of 2019, the 2019 Statement of Activity represents only six months out of the entire year. It is important

to note that the 2019 Net Revenue is vastly higher than any other year because as part of the split from the LGBT Center of Raleigh, the organization was given a \$50,000 deposit for the revenue from 2013 to June 2019. Therefore, absent that deposit, the club had a Net Revenue of \$6,306.07 from its regular activities. ### 2020

2020 was an extremely challenging year as COVID-19 forced the cancellation of all sports for



Spring, Summer, and Fall. This was the first time since the inaugural season in 2013 that the organization was forced to cancel a season. As it's shown in the financial statements for the year, COVID affected the organization negatively as well since fixed expenses were still incurred during the year and Spring field/court rentals & shirts were already paid for Therefore, no sports fees could be collected for most of the year and previously collected Springfees were

refunded (if requested during the proper time period). I'm proud that the organization was able to host a few Member Events and Fundraising Events even though sports did not happen. The below chart shows Fundraising Events and Member Events Stonewall Sports Raleigh Inc hosted throughout the year.

2021

# 2022 Planned Events

Since the organization's inception in 2019, there has not been a full year without a cancelled season and the presence of COVID-19. This has resulted in minimal hosted events for Stonewall Raleigh members and even fewer fundraising opportunities. With the start of 2022 and Winter



sports, the Board and Social Events and Outreach Committee are hoping for an entirely fresh start for everyone.

The Social Events and Outreach Committee (SEOC) is responsible for planning and executing league-wide monthly and quarterly events, as well as community outreach opportunities. Events and Outreach opportunities are to be planned a season in advance

to allow for Board Approval and proper planning. The SEOC meets as a group once a month to plan and coordinate their activities and committee updates.

The SEOC has been hard at work to plan out and finalize Stonewall Raleigh Member events for the first half of the year (second half is still being approved). The organization is so happy to


have sports and member social events back! Please take a look at the future events for 2022 and be on the lookout for the specifics around each event as it happens.

One major plan for 2022 includes donating more money to local North Carolina organizations and to start this year, we are making a pledge to donate to both the LGBT Center of Raleigh and InsideOut180. The LGBT Center of Raleigh has been a partner of Stonewall Sports Raleigh for almost ten years.
